

CAA Charity Golf Tournament Contest Rules

1. **Contest Period/Eligibility**. The CAA Charity Golf Tournament Contest (“**Contest**”) is open 7:00 a.m. – 3:00 p.m. ET on September 9, 2026 (“**Contest Period**”) at Angus Glen Golf Club in Markham, Ontario (“**Event**”). The Contest is open to legal residents of Canada who are amateur golfers and invited and registered participants at the Event. By participating in the Contest, each entrant agrees to abide by and be bound by these Official Rules and all decisions of CAA Club Group (“**CAA**”).

2. **How to Enter**.

Hole-in-One Prizes: To enter for a chance to win a hole-in-one-prize, complete your entire round (with scorecard) in a minimum group of three players (no twosomes), and follow the directions of the contest rules to take one stroke at the tee of one of the marked hole-in-one holes at the Event. One hole-in-one entry per person during the Event (no practice shots or mulligans allowed).

Tournament Prizes: To enter for a chance to win one of the six tournament prizes, follow the Event rules and the rules noted at each of the marked holes at the Event. For the Closest to the Pin, Closest to the Rope, Longest Drive, and Putting Competition prizes, no practice shots or mulligans allowed. One entry per person per tournament prize during the Event.

Player Appreciation Prize: Registered golfers at the Event will automatically receive one entry for a chance to win the player appreciation prize.

3. **Prizes**.

Hole-in-One Prizes: There are two \$50,000 CAD hole-in-one prizes available to be won (one on the North course and one on the South course), to be awarded in the form of a voucher to be used toward the purchase of a vehicle at a Weins Auto Group location.

Tournament Prizes: There are ten tournament prizes available to be won: (i) eight contest prizes each consisting of one gift card in the amount of \$25 (Closest to the Pin North Course, Closest to the Pin South Course, Closest to the Rope North Course, Closest to the Rope South Course, Longest Drive North Course, Longest Drive South Course, Putting Competition North Course and Putting Competition South Course), and (ii) two tournament prizes each consisting of a trophy for each player (approx. value \$75 each, for Most Honest and Tournament Winner).

Player Appreciation Prize: There is one player appreciation prize available to be won, consisting of one gift card for \$100.

Prizes must be accepted as awarded and may not be substituted except at CAA’s sole discretion. CAA reserves the right to substitute a prize of greater or equivalent monetary value if it cannot be awarded as described for any reason. CAA will not replace any lost or stolen prizes. Any other costs associated with the prizes not specified herein are the winners’ responsibility.

4. Winner Selection.

Potential winners will be notified at the Event and must be present at the time of notification.

Hole-in-One Prizes: To win a hole-in-one prize, participant must hit a golf ball from the designated tee to the designated hole, in one stroke. Hole-in-one winners will be subject to confirmation by onsite witnesses/monitors. Chances of winning depend on golf skill. CAA may at its discretion require hole-in-one winners to complete and return a written declaration and release form, releasing CAA from any liability in connection with this Contest or the use, misuse, awarding or possession of any prize.

Tournament Prizes: To win one of the tournament prizes, follow the Event rules and the rules at the designated tournament contest holes. Tournament prize winners will be subject to confirmation by onsite witnesses/monitors. Chances of winning depend on golf skill.

Player Appreciation Prize: During the Event, CAA will conduct a random draw from among all eligible entries for the purpose of selecting one potential player appreciation prize winner. Odds of being selected depend on the number of eligible entries received during the Contest Period. Potential player appreciation prize winner will be required to correctly answer a time-limited skill-testing question without assistance of any kind.

- 5. Miscellaneous.** Contest is subject to all applicable laws. CAA reserves the right to correct any errors. CAA's failure to enforce any term of these Rules shall not constitute a waiver of that provision. The invalidity or unenforceability of any provision of these Rules shall not affect the validity or enforceability of any other provision. CAA reserves the right, in its sole and absolute discretion, to administer an alternate test of skill as it deems appropriate or necessary to comply with applicable law. Should a winner make any false statement(s), the winner shall forfeit their prize or the cash value thereof. CAA reserves the right to terminate, suspend or modify this Contest, in whole or in part, at any time and without notice or obligation if, in CAA's sole discretion, any factor interferes with its proper conduct as contemplated by these Official Rules. BY PARTICIPATING, YOU RELEASE CAA FROM LIABILITY FOR ANY INJURIES, LOSSES OR DAMAGES OF ANY KIND (INCLUDING DIRECT, INDIRECT, INCIDENTAL, CONSEQUENTIAL OR PUNITIVE DAMAGES) TO PERSONS OR PROPERTY RESULTING FROM THE CONTEST, INCLUDING THE ACCEPTANCE, POSSESSION, MISUSE OR USE OF THE PRIZE, OR THE MERCHANDISE FOR WHICH IT IS REDEEMED (IF APPLICABLE).
