CAA SOUTH CENTRAL ONTARIO ENCHANTED EUROPE GIVEAWAY CONTEST – CONTEST RULES

ELIGIBILITY

1. WINNER CONFIRMATION

- 14. Selected entrants will be notified at the phone number or email address provided at the time of entry. No communication or correspondence will be entered into, except with selected entrants.
