

**CAA SOUTH CENTRAL ONTARIO
CAA TRAVEL EXPO – CONTEST RULES**

CONTEST PERIOD AND ELIGIBILITY

1. The CAA Travel Expo (“**Contest**”) sponsored by CAA Club Group (operating as CAA South Central Ontario) (“**CAA**”) is open 09:00:01 a.m. ET on March 4, 2024 and ending at 3:00:01 p.m. ET on April 14, 2024 (“**Contest Period**”) to persons who reside within the club territory of CAA South Central Ontario, and have reached the age of majority in the Province of Ontario (18 years of age) as of the date of entry for the Contest with the following exceptions: employees and retirees of CAA and its affiliates, partners, suppliers, representatives, agents, advertising and promotional agencies, the independent contest agency if any, and the household members and Immediate Family of any of the above are not eligible to participate in the Contest. For the purpose of these Contest Rules, “**Immediate Family**” means spouse, mother, father, brother, sister, son or daughter, whether or not they reside in the same household.

HOW TO ENTER

2. NO PURCHASE NECESSARY.

Eligible participants may enter the contest:

By attending the CAA Travel Expo:

- i. Participants must register for the CAA Travel Expo event (“**Event**”), as defined below online on the Eventbrite website (<https://www.eventbrite.com/cc/caa-travel-expo-xxx>) or at caasco.com/expo; and
- ii. Attend the event in-person to enter the contest during the “**Event Period**”, as defined below.
- iii. Early Registration Bonus

Participants who register for the **event** before 11:59:59 p.m. ET, March 30, 2024 will receive one bonus entry. To qualify for the bonus entry, entries must be received by 11:59:59 p.m. ET, March 30, 2024 and the participant must attend the **event** in-person during the “**Event Period**”. Only one bonus entry will be awarded per person. The bonus entry will not affect the odds of winning for participants who enter after April 1, 2024. The determination of eligibility for the bonus entry will be made by the sponsor. This bonus entry is non-transferable and has no cash value.

Participants must ensure that they check-in their attendance at the event reception during the “**Event Period**” to be eligible. Participants will be automatically entered into the contest once they checked in.

THE DRAWS

7. Three (3) Prize winners (“**Winner(s)**”) will be selected by random draw from all eligible entries received during the Contest Period. The decision will be made by CAA on April 24, 2024 at 2:00 p.m. ET at its head office located at 60 Commerce Valley Drive East, Thornhill, ON.
8. The odds of winning a Prize will depend on the number of eligible entries received during the Contest Period.

WINNER CONFIRMATION AND PRIZE CLAIM CONDITIONS

9. Selected entrants will be notified by telephone at the number provided at the time of entry, and are subject to verification by CAA and/or its designated representatives, in their sole discretion. No communication or correspondence will be entered into, except with selected entrants.
10. To be confirmed a Winner, the selected entrant must:

- (a) confirm compliance with these Contest Rules;
 - (b) accept the Prize as awarded;
